To Our Donors,

The Community Fund is pleased to present our 2024 Annual Report, detailing the impact that your donations have made on the Bronxville, Eastchester, and Tuckahoe community for the period July 1, 2023 through June 30, 2024. Thanks to the generous contributions of donors throughout our area, we were able to allocate **\$551,173** in total grants, providing support to 24 social service agencies and local community programs that assist all residents of Bronxville, Bronxville P.O. Eastchester, and Tuckahoe.

Highlights of the Community Fund's year include:

- Over **\$59,000** was awarded in one-time discretionary grants that supported the ongoing mental health crisis in our community, capital improvements to our libraries, and senior service support.
- More than **\$500,000** in ongoing support for our member agencies that affect Senior Services, Youth Initiatives, Family Support, Health and Wellness Programs, and Education and Prevention Services.
- Provided over **400** volunteer hours to our local service agencies and community programs though our annual review grant allocation process.
- Engaged local high school students in philanthropy and grantmaking with YCF
- Galvanized support of our Comprehensive Needs Assessment in partnership with Pace university and created the Mental Health Fund.

Our ability to support the community is made possible by our generous donors. The Community Fund understands the needs of our residents and channels our resources towards the most effective programs that provide the greatest impact. We distribute 100% of donations made to our Annual Campaign toward the grants we distribute. Thank you for your ongoing support.






TOTAL COMMUNITY INVESTMENT FY 2024 \$555,195 FY 2025 \$543,213



Community Investments by Demographic Sector FY 2024 and FY 2025





Our Grant Process



The Community Fund evaluates grant proposals and designates donor dollars through 3 different grant processes.

This year we were able to harness the power of over 200 volunteers to disperse \$550,000.

1. Member Agency Fund Grants

Agencies which receive funding for their operating and administrative budget as well as for program support are considered **"Community Fund Member** Agencies." Member Agencies are nonprofit organizations and community programs that service the Bronxville, Eastchester, and Tuckahoe communities and fall into 5 Sectors of Impact: Youth, Seniors, Education and Prevention, Family, and Health. Individual grants range from \$2,000 to \$60,000 yearly.

2. Mental Health and Discretionary Fund Grants

Discretionary grants are meant to fund either a specific time-limited project/program or provide seed money for a new initiative. Programs in this category are generally funded for one year and a maximum of \$10,000 is dispersed. These one-time grants give The Fund the flexibility to help support an immediate need with an agency or community program, or seed a new initiative that can dramatically impact the lives of our residents. In the last 10 years The Fund has given over \$225,000 in this special funding.

3. Youth Community Fund Grants

Youth Community Fund grants aimed at supporting local youth initiatives that YCF deems appropriate. Grants are supported through YCF fundraising efforts.

Youth Community Fund of BET

A subset of The Community Fund, the Youth Community Fund of BET teaches area high school students the value of philanthropy and community service. Launched in 2019, more than 100 area high school students join the YCF each academic year. Members organize and participate in community service events, volunteer opportunities, and fundraising drives, all with a focus on serving the needs of vulnerable youth in our area.

2023-2024 marked another busy year of exciting, teen-focused programs and volunteer opportunities:

Bronxville Ballet Not For Sale Dance

Classes ran from September to May. The program last is 2x month this year and a new holiday social was enjoyed by all who participated. This program was funded with grant money awarded by YCF in 2022-2023. A screening of the award-winning documentary Liked was held at The Bronxville Picture House on April 3rd. This was YCF's second film screening and originated from a grant written by YCF members. The event welcomed more than 65 Bronxville, Eastchester and Tuckahoe teens and their parents and served as a conversation spark about teen anxiety and mental wellness and how social media impacts young people. YCF volunteers staffed and promoted this free community screening. Several students took the stage to give background on the program and lead a group activity for the audience.

YCF volunteers donated their time to several community service events throughout the year on a few volunteer projects.



Members of YCF's **Evaluations Committee** shadowed The Community Fund's grant evaluation program, learning from the 30 adult community volunteers who lead this community initiative each year. Students were able to read grant applications, attend and participate in evaluation interviews, and attend the agency presentation evening. The group will be voting to distribute \$5000 to worthy organizations in June. The group received grant applications for the following

Behind the scenes, YCF members have written articles and social media posts, organized meetings and events, and sharpened their public speaking skills.





YCF membership is open to 9th – 12th graders residing in Bronxville, Eastchester and Tuckahoe. There are leadership opportunities for 11th graders.
